METHOD: With reference to EN71-3: 2019 + A1:2021. Analysis of general elements was performed by ICP-OES. Chromium (III) was obtained by calculation, Chromium (VI) was analyzed by IC-UV/VIS / IC-TLD / LC-ICP-MS / LC-DAD / IC-ICP-MS. Organic Tin was analyzed by GC-MS.


